## **Rebalancing the Rights of Importers and Exporters: How to Address Agricultural Export Restrictions?**

### **Abstract**

Over the past 4 years, food prices repeatedly jumped to “crisis” levels. Over two dozen governments, all from low and middle income countries, have responded with policies that curtail exports of agricultural products in order to promote national food security. Such measures have been shown to trigger further price increases on the world market, and to make world markets a less reliable source of food supplies in both the short and long run.

The existing international trade rules entail few disciplines on export restrictions, and are primarily focused on the rights of exporters. There have been proposals to put into place greater rights for importers, most recently from G-20 agricultural ministers and from the group of low income net food importing countries, as part of the Doha Round negotiations.

This session will examine the motivations behind and impacts of agricultural export restrictions in countries that impose restrictions. The session will also examine the impact of export restrictions on food price volatility and access to food in low-income food importers, in particular in the LDCs.

The session will also explore whether and how international trade disciplines on agricultural export restrictions can be improved. What kinds of rules regarding notification, limitation and special & differential treatment should the international community agree to with regard to agricultural export restrictions? A panel of ambassadors and policy advisors will examine the political factors that must be taken into

account when advocating for rules governing export restrictions. The ultimate aim is to speed up the process towards much-needed progress on this dossier.

## Speaker biographies

**Dr. Debapriya Bhattacharya** is the Special Advisor on LDCs at UNCTAD. He is a macro-economist and a public policy analyst, the former Ambassador and Permanent Representative of Bangladesh to the United Nations Office, World Trade Organization (WTO) and other International Organizations in Geneva, and Bangladesh's Ambassador to Vatican. Prior to his this post, he was the Executive Director of the Centre for Policy Dialogue (CPD) – a leading think tank in South Asia. He has earlier worked as a Senior Research Fellow at the Bangladesh Institute of Development Studies (BIDS).

**Bipul Chatterjee** is Deputy Executive Director, CUTS International, a leading economic policy research, advocacy and networking, non-governmental group with its headquarters in Jaipur, India and offices in Geneva, Hanoi, Nairobi and Lusaka. He has published/edited several books and papers on political economy of trade and development. Recently he has co-edited with Pradeep S. Mehta an anthology titled "Growth and Poverty: The Great Debate". Other than managing trade-related projects, his responsibilities include fundraising, human resource development and knowledge management. He is a Member of the Planning Commission of India's Working Group on Boosting Manufacturing Exports during the 12<sup>th</sup> Plan, 2012-17.

**Nicholas Imboden** is Executive Director and cofounder of IDEAS Centre. He held senior executive positions at SGS, the regional development banks (ADB, AFDB, IDB) and the EBRD. He was the Swiss negotiator for market access and agriculture during the Uruguay Round negotiations (1987-1992). He has been a member of the Board of the Foundation of the "Institut Universitaire d'Etudes de Développement" (Geneva) and of the International Institute for Sustainable Development (IISD) in Canada. He has also been a member of various Expert Groups of the World Bank, Inter-American Development Bank and of the UNDP Human Development Report.

**Dr. Dmitri Rylko** is executive director at the Institute for Agricultural Market Studies (IKAR), a Moscow-based consultancy firm engaged in analysis of the domestic Russian and global agricultural and food systems. Over his professional carrier, Dmitry has worked as consultant for international institutions and private entities in Russia, Ukraine and Kazakhstan. A decade ago he conceptualized the "new agricultural operators in Black Sea FSU countries". In the 2010/11 marketing year he was member of the ad hoc working group on drought by the Russian government. Recently he assumed membership of the working group by the government of Russia on the development of new Agricultural Program, 2013-2020. He also has ongoing assignments with FAO and the European Bank for Reconstruction and Development.
